

In producing herewith, the 09 (Nine) persons namely 1.Prakash Mahato (21) S/O Baldeb Mahato of Vill-Keruari, PS-Jhalda, Dist-Purulia 2. Panchanan Mahato (43) S/O Sabharam Mahato of Vill-Chaupad, PS-Jhalda, Dist-Purulia 3.Sushen Mahato (42) S/O Gurupada Mahato of Vill-Bansa, PS-Jhalda, Dist-Purulia 4. Abhijit Mahato (19) S/O Rupshi Mahato of Vill-Bhakuyadih, PS-Jhalda, Dist-Purulia 5.Bhagirath Mahato (22) S/O Sonu Mahato of Vill-Latar, PS-Jhalda, Dist-Purulia 6. Rajkumar Mahato (28) S/O Harendranath Mahato of Vill-Bondih, PS-Jhalda, Dist-Purulia 7. Kunal Mahato (23) S/O Harendranath Mahato of Vill- Keruari, PS-Jhalda, Dist-Purulia 8. The fact of the case in a nut shell is that SI Jayanta Kr. Chakraborty of Tulin OP along with force namely (i) C/2419-Kanai Soren (ii) C/2487-Kamal Mahato was performing the naka duty at Maru more on Jhalda Ranchi road from 15:55 hrs. on 22/07/21 for the implementation of the Govt Order regarding all to were Mask. This refers to Tulin OP under Jhalda PS GDE No 596 dtd.22.07.2021 in consonance with C.C No 946/21 Dtd. 22.07.2021. During the naka duty at Maru more, He intercepted the following above noted 09 (Nine) persons noted in the supra (SI no 1-9), who were loitering aimlessly without wearing the mask and not maintaining the social distance. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted loitering after violating the Government Order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and dis...eyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021 in consonance with order promulgated by Govt. of West Bengal vide Memo No 486-CS/2021 dtd 24/04/2021 following with the order of Govt. of West Bengal vide Memo No-647-ISS/2M-22/2020 dtd 15/05/2021 and Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21 and Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21. Ergo, they can be booked U/S 188 of the IPC and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act. 1897. Ergo a specific case may kindly be initiated against them and arranged for its investigation.
