Sir,

In producing herewith 01 (one) arrested accused person Paresah Mahato (38 yrs) S/o-Ajit mahato of Vill-Purda PS-Purulia (M) Dist- Purulia, under arrest along with seized articles as per seizer list i.e. 10 (ten) Liter ID liquor (Mohula) under proper seizure with label.

I ASI Tarapada Hazari of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (25/07/2021) at about 16:55 hrs when myself along with C/997 Rajkumar Bauri & NVF/659 Bhaskar Mahato were performing special mobile duty vide Joypur PS CC No-2787/21 Date-25/07/2021, as per my source information I reached at Near Electric office (Sub Station WBSEDCL) under Joypur PS and found that the above noted accused person selling Id liquor (Mohula) in the open place Near Electric office (Sub Station WBSEDCL). On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 10 (ten) liter of Illicit Liquor which was kept in open place in a jarican. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the open place Near Electric office (Sub Station WBSEDCL). On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 17:25 hrs to 17:35 hrs & label duly signed by him and other available witness after taking 300 ML. as sample in a separate bottle from the Jarican.

During further interrogation he confessed his guilt as such I arrested him today 25/07/2021 at 17:45 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Paresah Mahato (38 yrs) S/o-Ajit mahato of Vill-Purda PS-Purulia (M) Dist- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
