Sir,
In producing herewith 01 (one) arrested accused person Lambador @ Jom @ Lambu Mahato (30 yrs) S/o-Late Samir Mahato of Vill-Palanja PS-Joypur Dist-Purulia under arrest along with seized articles as per seizer list i.e. 10 (ten) Liter ID liquor (Mohula) under proper seizure with label.

I ASI Dhritiman Rakshit of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (30/07/2021) at about 06:25 hrs when myself along with C/-997 Rajkumar Bauri & NVF/-018 Biswanath Mahato were performing anticrime night mobile duty vide Joypur PS CC No-2641/21 Date-29/07/2021, as per my source information I reached at Forest under Joypur PS and found that the above noted accused person selling ld liquor (Mohula) in the open place at Forest More. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 10 (ten) liter of Illicit Liquor which was kept in open place in a bottle. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the open place at Forest More. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the ld liquor illegally without any documents. So I seized the same under proper seizure list on 30/07/2021 in between 06:10 hrs to 06:20 hrs & label duly signed by him and other available witness after taking 300 ML as sample in a separate bottle from the Jarican.

During further interrogation he confessed his guilt as such I arrested him today 30/07/2021 at 06:25 hrs hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Lambador @ Jom @ Lambu Mahato (30 yrs) S/o-Late Samir Mahato of Vill-Palanja PS-Joypur Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
