Sir,

In producing herewith 02 (two) arrested accused persons (1) Mantu Ghasi (32 yrs) S/o-Late Tarani Ghasi of Vill-Chapaitard nitchpara (2) Shib Charan Ghasi (35 yrs) S/o-Kambhu Ghasi of Vill-Hatimuri both of PS- Joypur Dist- Purulia, under arrest along with seized articles as per seizer list i.e. 20 (twenty) Liter ID liquor (Mohula) under proper seizure with label.

I SI Nagendra Nath Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused persons, to the effect that on today (06/07/2021) at about 19:25 hrs when myself along with C/-3007 Amit Rajak & C/-2569 Bikram Kalindi were performing special mobile duty vide Joypur PS CC No-2549/21 date-06/07/2021, as per my source information I reached at Chapaitard nitchpara under Joypur PS and found that the above noted accused persons selling Id liquor (Mohula) in the house of Mantu Ghasi. On seeing Police persons, they conceal their presence at that house, but on searching we able to trace out them and also to found that 20 (twenty) liter of Illicit Liquor which was kept conceal at his house. On being asked they disclosed their name and address as noted above. On interrogation they stated that they were selling Illicit liquor to the local people in his house at Chapaitard Nitchpara. On demand they failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that they were selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 20:35 hrs to 20:40 hrs & label duly signed by them and other available witness after taking 300 ML as sample in a separate bottle from the Jarican.

During further interrogation they confessed their guilt as such I arrested them today 06/07/2021 at 20:35 hrs to 20:40 hrs as the accused persons are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely (1) Mantu Ghasi (32 yrs) S/o-Late Tarani Ghasi of Vill-Chapaitard nitchpara (2) Shib Charan Ghasi (35 yrs) S/o-Kambhu Ghasi of Vill-Hatimuri both of PS- Joypur Dist- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
