Sub: Prayer for lodging F.I.R. against arrested accused persons namely Samsher Ansary (26 yrs) S/o-Siraj Ansary of Vill-Uparkahan PS-Joypur Dist-Purulia & 09 others.

Sir,

With due respect I SI Prabir Kr Dey of Joypur PS, beg to submit before you that on 27/07/2021 at about 20:25 hrs while myself along with force were performing Special Mobile duty at PS area and conducting raid against non-wearing of mask physical distancing maintaining at Atakol More as per order of my superior vide Govt. Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and Order No-753/III-ISS/2M-22/2020 Date-14/07/2021, Joypur PS GDE No-1335 Date-27/07/2021 & CC No-2611/21 Date-27/07/2021 and found the following persons were roaming at Joypur Bazar without any face cover / mask & were gather at Atakol more without maintaining physical distancing. Inspite of several request & reminder they refuse to wear mask and roaming at public place. To prevent the spread Covid-19 pandemic situation, I asked them to wear mask but they did not comply my request & roaming in the Atakol more without face cover / mask. Myself along with accompanied force detained them at Atakol more they were coming from others villages. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by Government order vide Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distancing norms should be strictly dealt with and Order No-753/III-ISS/2M-22/2020 Date-14/07/2021. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons were arrested on 27/07/2021 from 21:05 hrs to 21:30 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.

- (4) Rajesh Kumar (26 yrs) S/o-Anadi Kumar of Vill-Nutandih PS-Joypur Dist-Purulia
- (5) Niranjan Mahato (56 yrs) S/o-Dukhu Mahato of Vill-Boruadih PS-Joypur Dist-Purulia
- (6) Dilip Gope (29 yrs) S/o-Shyamapada Gope of Vill-Dhabani PS-Joypur Dist-Purulia.
- (7) Sishupal Kumar (20 yrs) S/o-Falari Kumar of Vill-Nutandih PS-Joypur Dist-Purulia.
- (8) Rakesh Kumar (20 yrs) S/o-Janaradan Kumar of Vill-Tatuara PS-Kotshila Dist-Purulia.

All the arrested accused persons are liable for prosecution U/S-269/188/34 IPC & 51 (1) (b) of Disaster Management Act, 2005.

As the offence is bailable, So all the arrested accused persons were released on bail after obtaining bail bond vide Joypur PS GDE No-1348 Date-27/07/2021.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S - 269/188/34 IPC & 51 (1) (b) of Disaster Management Act, 2005. Copy of order attached herewith.
