Respected Sir,

In producing herewith arrested accused Gurupada Modak (31 years), S/O Pramatha Modak of vill - Gamarkuri, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 30.07.2021 at 18.15 hrs during my mobile duty received telephonic information that the above noted accd selling liquor at Gamarkuri More in the sweets and tea shop. Accordingly I, SI Kalyan Kr Sakha along with C/2987 Gurudas Malla and NVF/0241 Surja Sing Sardar reached at Gamarkuri More sweets and tea shop of the above noted accused at 18.35 hrs and found that one person was selling Liquor sweets and tea shop. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 18 (Eighteen) Bottle CS liquor brand as "Dil Khush" 300 ML each out of this 18 bottles 01 bottle took as sample with sealed and labeled (2) One white colour jarikin loaded with 05(Five) liters ID liquor (Chullu) out of seized ID liquor 300 ml taken out in a separate container as sample with sealed and labeled. I also seized and labeled all the seized articles at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person at 19.15 hrs u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with above noted seized articles.

Therefore I pray before you that kindly arrange to start a specific case u/s 46(A)(c) B.E. Act 1909 against arrested accused Gurupada Modak (31 years), S/O Pramatha Modak of vill - Gamarkuri, PS - Kashipur, Dist - Purulia and arrange for its investigation.
