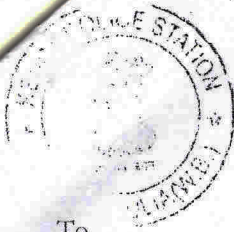

Sub: Request for lodging FIR against arrested accused persons.

Sir,

I, ASI Prasanta Sanyal of Kenda PS, Dist- Purulia in producing herewith the following accused persons namely (i) Sirdhartha Sankar Patra (32 Yrs.) S/o- Gobardhan Patra of Vill- Penra, PS -Tamna, Dist-Purulia (ii) Arabind Kora (26, S/o- Margal Kora of Vill. Raghunathpur, PS Nindih, Dist. Saraikella- Kharswa (Jharkhand), (iii) Nirmal Hembram (32) S/o Satish Hembram of Vill- Singhraidih, P.S- Boro, Dist- Purulia, (iv) Nepal Ch. Mahato (23 Yrs.), S/o- Prafullaya Mahato of Vill- Bharatdih, PS- Kenda, Dist- Purulia & (v) Somlal Kisku (21 Yrs.) S/o- Makar Kisku of Vill- Dumurdih, PS- Tamna, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 09/07/2021, as per direction while I along with C/ 2644 Mithun Duley & HG/1923 Banamali Manky both of Kenda PS engaged in day mobile duty at Kenda PS area and while we reached at Kenda bazar under Kenda PS at about 7.35 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and on seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
