I, ASI Nimai Rajwar of Kenda PS, Dist- Purulia in producing herewith the following accused Persons namely (i) Abhinash Mahato (20 Yrs.), S/o- Krittan Mahato of Vill- Surathdih, PS- Kenda, Dist-Purulia (ii) Sushen Mahato (19 Yrs.), S/o- Ajit Kumar Mahato of Vill. Murgadih, PS- Kenda, Dist- Purulia (iii) Sadhu Majhi (56 Yrs.), S/o- Haladhar Majhi of Vill- Bharatdih, PS- Kenda, Dist. Purulia, (iv) Gurupada Mahato (24 Yrs.), S/o- Fakir Mahato of Vill- Ulda , PS- Barabazar ,Dist. Purulia (v) Mangal Mahato (28 Yrs.) S/o- Chittaranjan Mahato of Vill- Bandwan, PS- Barabazar, Dist- Purulia & (vi) Prakash Mahato (47 Yrs.), S/o- Arjun Mahato of Vill- Bamunjora , PS- Barabazar ,Dist. Purulia do hereby lodge a written complaint against them to the effect that today on 14/07/2021, as per direction while I along with C/ 2644 Mithun Duley & HG- 1926 Bidhan Tantubai both of Kenda PS engaged in day mobile duty and while we reached at Kenda bazar under Kenda PS at about 14:25 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and on seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
