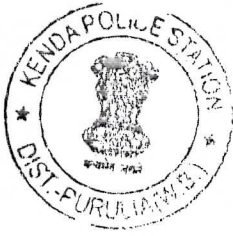

Sir,

I, ASI Nimai Rajwar of Kenda PS, Dist- Purulia in producing herewith the following accused Persons namely (i) Sona Singh Modak (22 Yrs.), S/o- Pintu Singh Modak of Dulmi Bhuinya Para, Near Kali Mandir, PS- Purulia Town, Dist- Purulia (ii) Ranjit Mahato (31 Yrs), S/o- Brinchi Mahato of Vill- Manguria, PS- Tamna, Dist- Purulia (iii) Bidhan Sing Sardar (21 Yrs), S/o- Haren Sing Sardar of Vill- Ghastoriya, PS- Manbazar, Dist- Purulia (iv) Manojit Chowdhury (23 Yrs), S/o- Swapan Chowdhury of Vill- Palma, PS- Kenda, Dist- Purulia (v) Chiranjit Majhi (20 Yrs.), S/o- Dhananjoy Majhi of Vill- Bharatdih, PS- Kenda, Dist- Purulia and (vi) Kshitish Mahato (21 Yrs), S/o- Dinabandhu Mahato of Vill- K.P. Lane, Purulia Municipality, Ward No- 07, PS- Purulia Town, Dist- Purulia and do hereby lodge a written complaint against them to the effect that today on 25/04/2021, as per direction while I along with C/2519 Arun Doloi & HG/1923 Banamali Manki both of Kenda PS engaged in day mobile duty at Kenda PS area. While we reached near Kenda bazar at about 14.45 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
