



### Most Respectfully begs to state as follows;

- 1. That the complainant and the witness are the of village Dimu, within police station

  Kotshila and the accused persons are village Chekya, within police station Kotshila

  and within the jurisdiction of this Court.
- 2.That the Coimplainant is the legally married wife of Radha Raman Gorait, the witness no 1, and the accused person no-1 is the husband, accused person no-2 is the father -in -law, accused person no-3 is the mother in law, accused person no -4 is the is the elder brother in laws wife i.e jaa and the accused no-5 is the jethi sasuri of the complainant.
- 3. That the complainant is the legally married wife of Radha Raman Gorait and their marriage has been solemnised in the month of Baishakh 1424 B.S corresponding to 14.05.2016 at village Dimu within Police Station Kotshila as per hindu right and customs prevailing in their society after negotiation.
- 4.That at the time of marriage the father of the complainant has given cash of Rs.100,000(one lac)


  Utensils ,Palank, Almirah Steel, Dressing Table ,ceiling Fan, Box , Chair & other things as per

  denmand of the accused person . After marriage the complainant came to her matrimonial

  house at village Chekya ,P.S-Kotshila within District —Purulia and lead their conjugal life with
  her husband and three daughters were born there .
- 5. That after born of the first daughter the complainant found that all the in laws of her matrimonial home are hot happy with the daughter, the husband of the complainant though happy with the complainant, and thereafter second daughter was born.
- 6. That after the born of the second daughter all above named in-laws of the complainant has used to started torture upon the complainant both mentally and physically.
- 7. That after few days born of the second daughter the torture upon the complainant increases day by day ,even the in laws did not supplied adequate food to the complainant, the complainant think that everything will be solved within few days and in that hope the complainant resided there.







- 8.That after few days the accused persons ask to the complainant to bring Rs. 50,000/from her father. The complainant informed the same to her father, but the father of the complainant informed her about his inability to fulfill such demand of dowry.
- 9.That when the complainant conveyed the same to the accused person, the accused persons started to ill treat and physically tortures the complainant and all the accused persons started ill treat to the complainant, they also lockup in a room to the complainant and four to five days torture the complainant rigorously. The complainant informed such tortured to her father through mobile phone and her came to village chekya and recovered his daughter from the matrimonial house of the complainant on 21.02.2021 with the advanced stage of pregnant condition and the third daughter born in the father house of the complainant.
- 10. That there after the father of the complainant tried to solved the dispute but due to the adamant attitude of the in laws of the complainant all such action went in vain . They have also abused him .
- 11. That during her stay at the matrimonial house the accused persons did not provide two square meals to the complainant and she has to do all the domestic works as a maid servant also misbehaved her.
- 12. That the complainant inform the matter to the local police station Kotshila through registered post on 15.03.2021 but the officer of the Kotshila, Police station assured the complainant to start a case but till today no case has been started by the Kotshila police.
- 13. That the complainant there after inform the matter to the Superintendent of Police on 19.04.2021 but no fruitful result .
- 14. That thus the complainant brought this Misc Petition for the offences committed by the accused persons for which he is liable to be prosecuted.
