Sir,

In producing here with 09(Nine) arrested accused persons namely 1. Sourav Chand (23) S/O Dilip Chand of village Manbazar Ganakpara PS Manbazar District Purulia, 2. Rahul Dutta (21) S/O Mahadeb Dutta of Village Paddarpara, PS Manbazar District Purulia, 3. Aman Das (21) S/O Uttam Kumar Das of Paddarpara Manbazar PS Manbazar District Purulia 4. Kousik Das (22) S/O Kashinath Das of village Poddarpara Manbazar PS Manbazar District Purulia, 5. Subrata Das (31) S/O Joydeb das of village Indkuri, PS Manbazar District Purulia, 6. Ranjit Singh (28) S/O Budheswar Singh of village – Popo, Po- Lata, PS Bandwan District Purulia, 7. Bharat Singh (26) S/O Rentu Singh of Village Digha, Po- Dhadka, PS Bandwan District Purulia, 8. I beg to state that today (08.07.2021), I was directed to find out whether the lock down has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No-325 dt. 08.07.21. Accordingly, I along with force had been at Manbazar market area and found no one is abiding the Govt. Announcement related to come down CIVID-19 pandemic situation. The above noted persons were walking freely and aimlessly in the public streets without wearing a mask in the night at about- 21:05 hrs at Manbazar post office more. Myself along with force detained them at Manbazar post office more under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for their movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 which is extended till now. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 753-ISS/2M-22/2020 dt- 14/06/2021 which is extended till now. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 IPC r/w 51 Disaster Management Act 2005. At prima facie there were sufficient evidences to secure their detention.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar through duty officer A.S.I. Sambal Singh for taking necessary action as per law. Memo of arrest, Inspection Memo.
