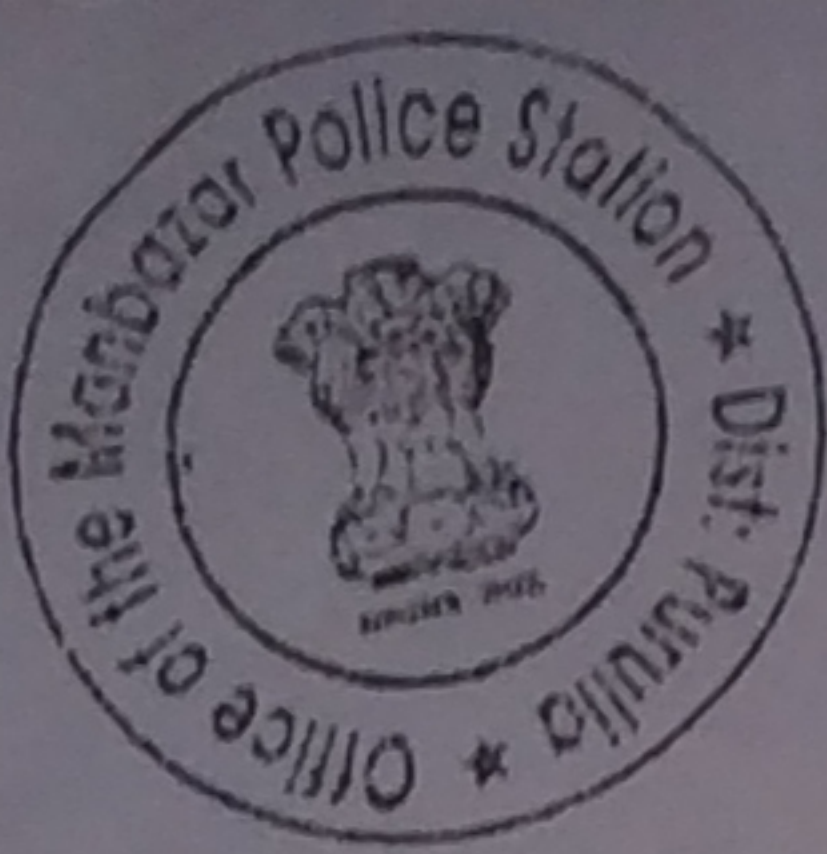

In producing here with 12(Twelve) arrested accused persons namely 1. Maniruddion Ansary (45) S/O Lt Ramjan Ansary of village – Bisri, PS- Manbazar, District- Purulia, 2. Bablu Bauri (26) S/O Bhandu Bauri of village- Manpur, PS Manbazar District- Purulia, 3. Sanjoy Mandi (27) S/O Malindra Mandi of village - Mahulbana, PS -Manbazar, District -Purulia, 4. Bibhuti Bhusan Singh Sardar (26) S/O Jihur Singh Sardar of village- Chalka , PS- Boro, District- Purulia, 5. Chandan Rajak (28) S/O Santi Rajak of village- Manbazar Rajakpara, PS- Manbazar, District- Purulia, 6. Ramdas Soren (47) S/O Sahebram Soren of village- Balidumi, PS- Manbazar, District- Purulia, 7. I beg to state that today (19.07.21), I was directed to find out whether the lock down has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No- 790 Dtd. 19.07.21 . Accordingly, I had been to market area side no one is listening dispute like perching in the area. The above noted persons walking freely in the public streets without wearing a mask. They are not following the rules and regulations of Corona disease at about- 22:05 hrs I found that the above noted persons were roaming aimlessly at bazaar area. Myself along with force detained them at Manbazar Gonesh Sweet more under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No- 40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 & 10/04/2020, and further notification dated 17.04.21 Govt of West Bengal vide No. 715- Home (Cons)/RIM(Cons)- 92/2021. for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till now. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act.
