I beg to state that today (21.07.21), I was directed to find out whether the lock down has been implanted properly at Manbazar Market area or not. This refers to Manbazar PS GDE No- 856 Dtd. 21.07.21 . Accordingly, I along with ASI Sambal Singh, C/119 Susanta Singha, HG/1443 Uttam Kumar Singh had been at Manbazar Bus stand and found the above noted persons were moving freely in that public place without wearing a Mask. Thus they violated COVID -19 protocol as promulgated by Govt. Of West Bengal Vide Order No-753/III – ISS/2M- 22/2020 dated 14.07.2020.and desperately to spare infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest.

All the process was done in between 21:25 hrs and 22:25 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar through duty officer S.I. Banshidhar Mukharjee for taking necessary action as per law. Memo of arrest, Inspection Memo.
