Sir,

In producing here with 16 (Sixteen) arrested accused persons namely (1) Sukdeb Rajak (28) S/o Manik Rajak of vill- Manbazar (Rajakpara) PS- Manbazar, Dist- Purulia (2) Biplab Mahato (23) S/o Chittaranjan Mahato of vill- Dighi (3) Sushil Mahato (23) S/O Bankim Mahato of vill- Kumari (4) Asim Mahato (26) S/O Shital Ch. I beg to state that today (27.07.21), I was directed to find out whether the lock down has been implemented properly at Post office Morh or not. This refers to Manbazar PS GDE No-1095 Dtd. 27.07.21. Accordingly, I along with C/1183 Subhas Kundu C/ 1252 Sunil Kr. Mandal had been at Manbazar, Post Office Morh and found the above noted persons were moving freely and aimlessly without wearing Mask, after 09 P.M. as restricted the unnecessary movement in that public place. Thus they violated COVID -19 protocol as promulgated by Govt. Of West Bengal Vide Order No-753/III – ISS/2M-22/2020 dated 14.07.2021 and they desperately act to spared infection of deceases which is dangerous to human life.

Being asked they failed to give any satisfactory answer for their movement in the night time at that place. So, I arrested them for Disobedience to order duly promulgated by Govt. of West Bengal. Observed all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them regarding the ground of arrest.

All the process was done in between 21:05 hrs to 22:20 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

On arrival at PS, I type this letter of complaint at Manbazar PS computer and submitted before OC Manbazar through duty officer ASI Anirban Banerjee for taking necessary action as per law.
