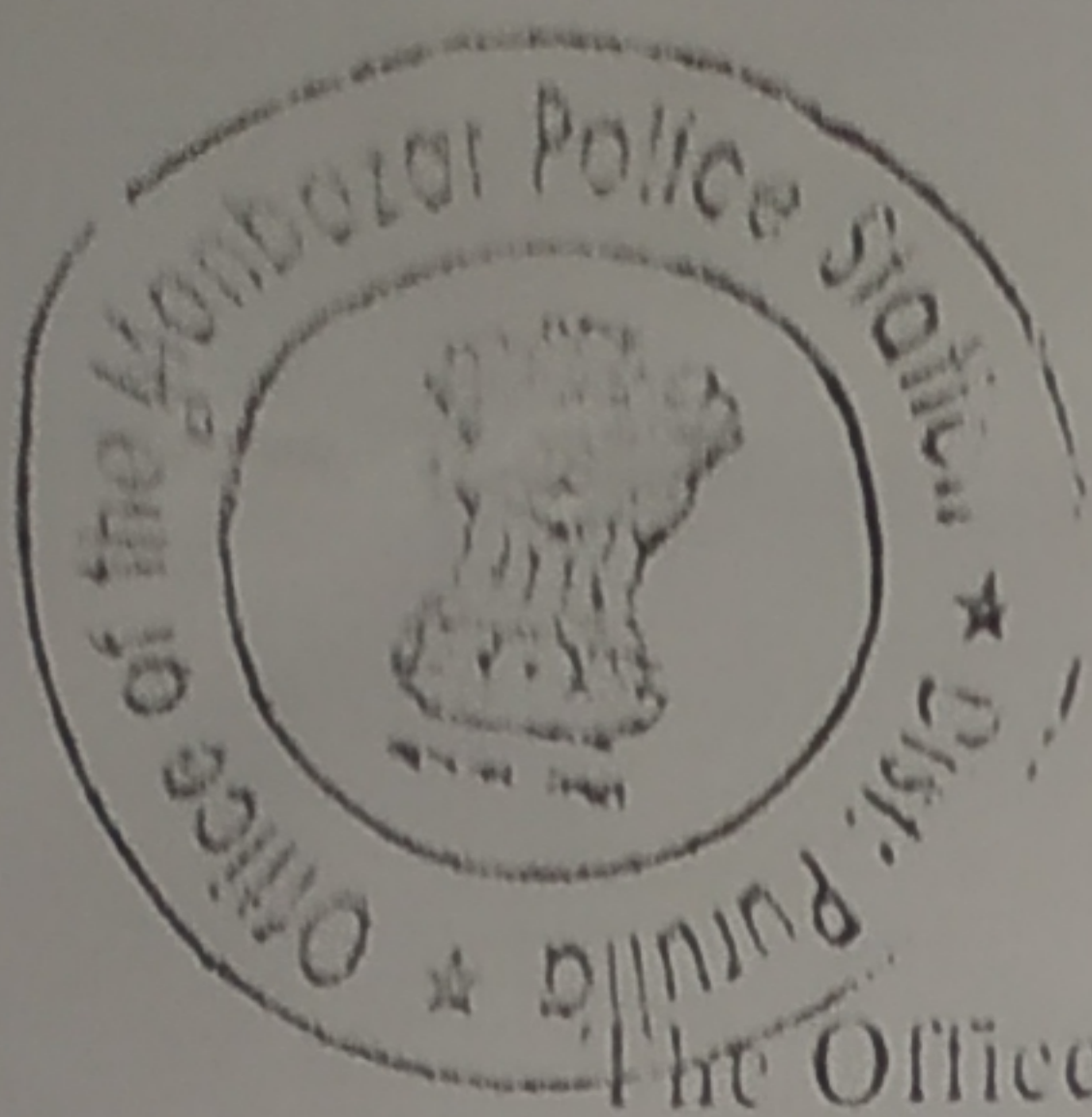
Action taken: Since the above mentioned persons are not known to the complainant, the case is registered and the investigation is transferred to P.S. Manbazar for further investigation.

I beg to state that today (30.07.21), I was directed to find out whether the lock down has been implanted properly at Manbazar Rural Hospital area. or not. This refers to Manbazar PS GDE No- 1188 Dtd. 30.07.2021. Accordingly, I along with C/ 496 Prakash Mahato NVF/537 Asit Kr Mahato had been at Manbazar Rural Hospital morh and found the above noted persons were moving freely in that public place without wearing Mask. Thus they violated COVID -19 protocol as promulgated by Govt. of West Bengal Vide Order No-753/III - ISS/2M-22/2021 dated 14.07.2021, Extended till 31 August 2021 and desperately to spread infection of deceases dangerous to life.

I arrested them for Disobedience to order duly promulgated by the Govt. of West Bengal as above after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest.

All the process was done in between 21:25 hrs and 22:40 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the town the peoples left the place and did not agreed to come forward to remain present.

After that I left for PS. On arrival at PS I type this letter of complaint at our PS computer and submitted to OC Manbazar PS through duty officer ASI Subhendu Mahato for taking necessary action as per law.
