Sub:- Complain for starting a specific case.

Sir.

In producing herewith one arrested accused namely Naran Bauri (28 Yrs) S/O- Mangal Bauri of Vill-Baghardanga, PS-Neturia, Dist-Purulia (Driver) and seized New Holland company tractor along with trolley having registration No- New, Chassis No- NHN30320ZLH516296 & Engine No-\$324F13566 loaded with sand approx 100 cft under proper seizure list. I beg to submit that I, \$I Abhijit Das along with C/78 Utpal Sarkar, C/1140 Dayamay Mahato and C/470 Somnath Nag all are of Neturia PS were performing day mobile duty vide Neturia PS CC·No- 1772/21 Dt. 09.07.2021 and at about 10:45 hrs received a credible source information that one tractor is standing at Chinakuri Ghat on Damodar river bed loaded with sand illegally. Accordingly I intimated the matter to you over phone, and as per your direction; we reached at Chinakuri Ghat to intercept the above noted tractor and at about 11:15 hrs found that above noted tractor ready to go from Chinakuri Ghat side but the vehicles suddenly stopped 30/50 meter away from us and one person from said vehicle seems to be the drivers of the vehicle got down from the vehicle and started running. We chased to apprehend the person and in spite of hot chase we managed to apprehend the above noted person. Then we searched the vehicle and found that the vehicle (Tractor) New Holland company having registration No- New, Chassis No- NHN30320ZLH516296 & Engine No- S324F13566 loaded with sand approx 100 cft. On being asked the detained driver, failed to produce any relevant documents in respect of loaded and as well as failed to produced vehicle related documents and on interrogation he stated that one Mrinal Bauri S/O- Mangal, Bauri of Vill- Baghardanga, PS-Neturia, Dist-Purulia is the registered owner of the above noted vehicle.

So, there is reason to believe that the driver of above noted vehicle and registered owner of this vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari side knowing it to be stolen, as per their regular practice.

Accordingly I seized the New Holland Company Tractor heaving Chassis No-NHN30320ZLH516296 & Engine No-S324F13566 along with trolley loaded with sand approx 100 C.F.T. under proper seizure list duly signed by witnesses and arrested the above noted accused driver after maintaining all formalities of Hon'ble Apex Court of India. So, the drivers of said tractor and registered owner of the said tractor have committed offence U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver of Tractor New Holland company Tractor heaving Chassis No- NHN30320ZLH516296 & Engine No-S324F13566 namely Naran Bauri (28 Yrs) S/O- Mangal Bauri of Vill-Baghardanga, PS-Neturia, Dist-Purulia, driver of said Tractor and registered owner of the said tractor namely one Mrinal Bauri S/O- Mangal Bauri of Vill- Baghardanga, PS-Neturia, Dist-Purulia U/S- 379/411/413/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange its investigation.
