In producing herewith five arrested accused persons namely 1) Sanjay Mondal (35) S/O- Rasbihari Mondal of Jharukhamar, Raghunathpur, Dist- Purulia (Rider of M/C No- WB82/9546 loaded with 100 Kg Coal approx). 2) Pagal Monda (52) S/O- Lt. Gopal Mondal of Do (Rider of M/C- WB82A/6917, loaded with 100 Kg Coal approx) 3) Bapan Mondal (36) S/O- Tinkori Mondal of Kharbari, PS- Raghunathpur, Dist- Purulia, ( Rider of M/C No – WB82C/2957 loaded with 100 Kg Coal approx) 4) Rahul Yadav (26) S/O- Ramesh Yadav of Kumardubi, PS- Chirkunda, Dist- Danbad, Jharkhand ( Driver of Auto No- JH21D/5399 loaded with 200 Kg coal approx ), 5) Shaktipada Mondal (46) S/O- Sadananda Mondal of Bartoria, PS- Neturia, Dist- Purulia (cyclist loaded with 50 Kg coal approx) , I, beg to submit that I, ASI Habibul Rahaman Mondal along with C/1303 Biswanath Majhi, NVF/711 Sunil Singh, & NVF /578 Niranjana Hembram all of Neturia PS while performing mobile duty 09.07.2021 at 13:45 hrs received a credible source information that some persons are transporting coal by their M/C, Auto, Bi-cycle towards Haridih through Purulia-Barakar pitch road which has been procured by means of theft or any fraudulent manner. After receiving the said information we have started towards Haridih more on that road under our P.S. jurisdiction with a view to intercept the said vehicles. At about 14:45 hrs we found some scooters, Auto, Bi-cycle loaded with coal in plastic sack are coming from Sarbori side. Seeing the police party all the drivers of the said vehicles left their vehicles on road started to fly away. However after a small chase we could able to detain 05 persons but rest fled away. On demand all the detained persons could not produce any valid document in respect of the procured coal as well as their vehicles. On verification it is reasonable to believe that the owner, driver of the said M/C, Auto, Bi-cycle and other collected the said coal either theft or any illegal means and transporting to run clandestine business for wrongful gain. So, I have seized the said M/C, Auto, Bi-cycle along with coal under proper seizure list and arrested the above noted accused persons. Other 03 or 04 persons fled away. There was no such public witness available at that time of seizure thereafter I brought the seized M/C, Auto, Bi-cycle along with coal at Neturia PS compound .

I, therefore pray before you to lodge a specific case against owner and driver of the M/C Auto, Bi-cycle and others under proper law.
