Sub: Complain to start a specific case.

Sir,

In producing herewith two arrested accused persons namely Bikram Mardi (38) S/O- Birbal Mardi of Vill-Laylam, P.O- Pagda, PS- Boram, Dist- East Shingbhum, Jharkhand (Driver of vehicle No- JH 05AQ/7534 and Sanatan Singh (52) S/O- Birbal Singh of Jerkha, PS- Patamda, Dist- East Shingbhum, Jharkhand ( Helper of the vehicle No- JH 05AQ/7534 along with one seized vehicle Dumper bearing registration No- JH 05AQ/7534 loaded with stone of 12 MT (Approx) do hereby lodge a complaint to the effect that on 09.07.2021 I, SI Banshi Lal Mahato, along with C/2165 Subhajt Tiwary and HG/1853 Ajanda Baskey all are of Neturia PS were engaged in NAKA checking duty vide Neturia PS GDE No- 357 Dt. 09.07.21. In course of Naka checking duty, at about 17:05 hrs received credible source information that one Dumper vehicle bearing registration No- JH 05AQ/7534 loaded with stone coming from Raghunathpur side procuring illegally and trying to transport the same to Asansol side through Purulia – Barakar road in clandestine manner. I immediately intimated you over phone and acquainted you about the information and you directed me to work out the information. In the mean time at about 17:45 hrs found that the above noted vehicle was coming from Raghunathpur side. We indicated the vehicle to stop and on checking it was found that the vehicle was matched given by source and found that approx 12 MT of Stone is loaded inside of the vehicle. Then I requested the driver to produce relevant documents/challan/cash memo in respect of loaded stone but he failed to produce any valid documents in support of loaded Stone as well as vehicle. On preliminary enquiry and as per statement of the restrained driver it could be learnt that he along with registered owner of the vehicle and owner of Stone have procured said Stone from different illegal source under Jharkhand state.

So, it is reasonable to believe that the above noted accused driver, helper, registered owner of the said vehicle and owner of Stone have obtained the said Stone either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same stone in a clandestine manner to Asansol side knowing it to be stolen, as per their regular practice.

Accordingly, I seized Dumper bearing registration No- JH 05AQ/7534 loaded with approx 12 MT of Stone under proper seizure list duly signed by available witnesses and also I arrested Bikram Mardi (38) S/O- Birbal Mardi of Vill-Laylam, P.O- Pagda, PS- Boram, Dist- East Shingbhum, Jharkhand (Driver of vehicle No- JH 05AQ/7534 ) and Sanatan Singh (52) S/O- Birbal Singh of Jerkha, PS- Patamda, Dist- East Shingbhum, Jharkhand ( Helper of the vehicle JH 05AQ/7534) in this case. In course of arrest I notified him ground of arrest, issued arrest memo U/S-50 Cr PC and brought him PS with loaded Dumper.

Under the above circumstances a specific case may kindly be started against Bikram Mardi (38) S/O- Birbal Mardi of Vill-Laylam, P.O- Pagda, PS- Boram, Dist- East Shingbhum, Jharkhand (Driver of vehicle No- JH 05AQ/7534 ) (2) Sanatan Singh (52) S/O- Birbal Singh of Jerkha, PS- Patamda, Dist- East Shingbhum, Jharkhand ( Helper of the vehicle No- JH 05AQ/7534) (3) Registered owner of vehicle having No- JH 05AQ/7534 and (4) Owner of stone seized from vehicle No- JH 05AQ/7534 under proper sections of law.
