Sir,

In producing herewith 06 (Six) arrested accused persons namely (1) Surajit Roy (38) S/O- Madhab Chandra Roy of Vill-Narayanpur, PS-Neturia, Dist-Purulia (2) Samiran Das (25) S/O- Subhas Das of West Apcar Garden, Asansol-04, PS-Asansol South, Dist-Paschim Burdwan, A/P- H/O- Raghunath Nath of Vill-Sarbari More, PS-Neturia, Dist-Purulia (3) Pranab Mukherjee (37) S/O- Gour Mukherjee of Vill-Benipur, PS-Neturia, Dist-Purulia (4) Rajesh Barhi (25) S/O- Motilal Barhi of Vill-Ahirbari, PS-Neturia, Dist-Purulia (5) Rajib Bauri (31) S/O- Sadha @ Sadhan Bauri of Vill-Baruipara, PS-Neturia, Dist-Purulia and (6) Sagar Bauri (25) S/O- Rasamoy Bauri of Vill-Kuthibari, PS-Neturia, Dist-Purulia, I, SI Chandan Kumar Sen of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 30.07.2021 while I along with C/470 Somnath Nag, C/584 Madhab Chandra Majee and NVF/578 Niranjana Hembram all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 1304 dated 30.07.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Sarbari More at about 17:45 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Sarbari More but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
