Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one arrested accused person namely Milan Mandal (22) S/O- Kajal Mandal of Vill-Benipur, PS-Neturia, Dist-Purulia with seizure of 17 pcs Sealed bottles of Dil Se Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (30.07.21) while I, ASI Habibul Rahaman Mandal, along with force were performing special mobile duty vide Neturia PS GDE No-1307 Dt. 30.07.21 and acting on source information after consulting you at about 21:05 hrs reached at Jhanka More and held raid in the hotel of Milan Mandal (22) S/O- Kajal Mandal of Vill-Benipur, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Milan Mandal failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 17 pcs Sealed bottles of Dil Se Country spirit containing 300 ml which were seized under proper seizure list duly signed by witnesses and labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Milan Mandal (22) S/O- Kajal Mandal of Vill-Benipur, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/470 Somnath Nag and (2) C/584 Madhab Chandra Majee and (3) NVF/578 Niranjana Hembram both of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Milan Mandal (22) S/O- Kajal Mandal of Vill-Benipur, PS-Neturia, Dist-Purulia under proper section of law.
