Sub: Complain to start a specific case.

Sir,

In producing herewith 07 (Seven) arrested accused persons namely (1) Manik Chandra Das (28) S/O- Sankar Ravidas of Vill-Dhabani, Dhandawar, PS-Putki, Dist-Dhanbad, Jharkhand, A/P- Sarbari, PS-Neturia, Dist-Purulia (2) Vivesh Kumar Jha (42) S/O- Lt. Bharat Jha of Vill+PO-Pandit Tola, PS-Bibhutipur, Dist-Samastipur, Bihar (3) Raju Sahish (32) S/O- Lt. Nalin Sahish of Parbelia Upardhawra (Kalimela), PS-Neturia, Dist-Purulia (4) Rabi Bauri (35) S/O- Lt. Gopal Bauri of Vill-Kuthibari, PS-Neturia, Dist-Purulia (5) Shibu Hansda (32) S/O- Shyamapada Hansda of Vill-Kuthibari, PS-Neturia, Dist-Purulia (6) Barun Maji (42) S/O- Gunadhar Maji of Vill-Puapur, PS-Neturia, Dist-Purulia and (7) Karunamoy Maji (46) S/O- Lt. Gunadhar Maji of Vill-Puapur, PS-Neturia, Dist-Purulia , I, SI Biswajit Banerjee of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 30.07.2021 while I along with C/470 Somnath Nag, C/584 Madhab Chandra Majee and NVF/578 Niranjan Hembram all are of Neturia PS as per direction engaged in special mobile duty in Neturia PS area, reference Neturia PS GDE No- 1304 dated 30.07.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazaar at about 21:35 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazaar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
