I, Sri Dhritiman Sardar aged about 24 years, son of Sri Rupal Sardar, Station Manager of Saltore Customer Care Centre, WBSSEDCL do hereby lodge complaint against Sri Manish Kahar, S/o- Unknown of Village- Amdanga, Post-Neturia, Dist-Purulia for giving strong obstruction to discharge official duty of WBSSEDCL representative.

As information received from the Representative of M/s- Fluentgrid Ltd (Sri Srikanta Mandal) who is engaged in Meter Reading & Billing activity which is directly connected to govt. revenue under Saltore Customer Care Center that he got a strong resistance while he was at Amdanga colony and on the way to the house of Sri Pradip Kumar Kahar, S/o- Babulal Kahar (One bonafied consumer with Con. Id-201659121 under Saltore CCC) .Where one Sri Manish Kahar physically assaulted him by punch on mouth and chest, tearing his cloths and forcefully detained him and obstructed him to discharge his official duty and for this he on behalf of WBSSEDCL unable to take meter reading to the remaining houses. He was released from that place by your active intervention for which this office is grateful to you. The original submission by representative of Fluentgrid Ltd has been attached herewith which will speak to itself.

We being an emergency service utility providing continuous service in this covid pandemic with the active participation of these workers so, it is requested to investigate the case in detail and help us to provide uninterrupted service on behalf of WBSSEDCL.
