Sub: Complain to start a specific case.

Sir,

In producing herewith 05 (Five) arrested accused persons namely (1) Purna Das Char (22) S/O- Ujjwal Char of Vill+PO-Tiluri, PS-Saltora, Dist-Bankura (2) Saheb Acharjee (24) S/O- Poresh Acharjee of Vill-Shialdanga, PO-Manihara, PS-Kashipur, Dist-Purulia (3) Bubai Paramanik (26) S/O- Subal Paramanik of Vill+PO-Tiluri, PS-Saltora, Dist-Bankura (4) Sailendra Kumar Singh (34) S/O- Ram Kishor Singh of Vill-Parbelia Kalimela, PS-Neturia, Dist-Purulia and (5) Kajal Mandal (26) S/O- Lt. Sakhai Mandal of Vill-Gopalpur, PS-Neturia, Dist-Purulia, I, SI Abhijit Das of Neturia PS, Dist- Purulia do hereby lodge a written complaint against the above noted accused persons to the effect that today on 29.07.2021 while I along with C/1303 Biswanath Majhi and C/1140 Dayamay Mahato both of Neturia PS as per direction engaged in evening mobile duty in Neturia PS area, reference Neturia PS GDE No- 1263 and CC No- 1949/21 dated 29.07.2021 for implementation of Government rules regarding lockdown Disaster Management Plan. While we reached at Parbelia Bazaar at about 21:15 hrs found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I asked them about their presence at Parbelia Bazaar but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. Accordingly, I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police.

Therefore, I pray a specific case may kindly be started against the above noted accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
