I received credible source information that one Parikshit Gorain (37yrs) S/o Lt- Ashok Gorain of Village- Dubra, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 15.45 hrs to 16.45 hrs I held raid in the shop of Parikshit Gorain (37yrs) S/o Lt- Ashok Gorain of Village- Dubra Bazar, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying liquor fled away, I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license in support of said ID Liquor. So I seized 16 (Sixteen) bottles of 'DIL KHUSH' country spirit containing 600 ml each which were kept in there under proper seizure list in presence of witnesses duly signed by them. I also arrested the above noted person maintaining all rules and guidelines provided by NHRC/WBHRC and informed his family members.
