Purulia with seized article i.e 18 (Eighteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list, I beg to submit that today (30.07.2021) during my Spl mobile duty. I received credible source information that one Sagar Gorain (26yrs) S/o Tapan Gorain of Village- Dubra bazar, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor at his hotel near Kankdiha more for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 17.05 hrs to 17.55 hrs I held raid in the hotel at Dubra Kankdiha more of Sagar Gorain S/o Tapan Gorain and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police party the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license in support of said ID Liquor. So I seized 18 (Eighteen) bottles of 'DIL KHUSH' country spirit containing 600 ml each under proper seizure list in presence of witnesses duly signed by them which were kept in there. I also arrested the above noted person maintaining all rules and guidelines provided by NHRC/WBHRC and informed his family members.
