I received credible source information that one Baban Gorain S/o Lt-Pradip Gorain of Village- Dubra Bazar, PS- Para, Dist. Purulia has stored huge quantity of ID Liquor at his hotel near Kankdiha more for selling. Accordingly I informed it to O/C Para PS and as per his instruction in between 17.25 hrs to 18.15 hrs I held raid in the hotel of Baban Gorain S/o Lt- Pradip Gorain of Dubra Kankdiha more, PS- Para, Dist. Purulia and found that the above noted person was selling country spirit contained in bottles named as "DIL KHUSH". On seeing Police the people who were buying liquor fled away. I asked the above noted person to produce license for selling such liquor, but he did not have any authorization or license in support of said ID Liquor.
