Sub: Humble request to stop unauthorised and illegal Online lottery, Fake Lottery Tickets and Satta that are being conducted in different parts and areas of PARA Police Station.

Respected Sir,

I the undersigned would like to inform you that in recent time various Illegal Online Lotteries, Fake Lottery Tickets and Satta, has emerged and is conducting business in different parts and areas of PARA Police Station. As a result of the same the sale of conventional paper lottery has dipped which inter alia is causing huge revenue loss to the Government of West Bengal.

I would further like to inform your good office that the Government of West Bengal alone has earned revenue of more than Rs.4750 crores by way of collecting SGST and along with Rs.4750 crores as CGST by the Central Government (together amounting to Rs.9500 crores) paid by the Distributor of the Lottery Tickets and further the Government of West Bengal also earned revenue through collecting Draw Charges against the Lottery Draws for the Tickets sold in the State of West Bengal.

It is also pertinent to mention here that by a Gazette Notification bearing Notification no. 637-FT, dated 21.05.2013, published on 22.05.2013, the Government of West Bengal was pleased to prohibited the sale of all types of Computerised and Online Lottery, within the State of West Bengal, on and from 21.05.2013.

Furthermore the sale and marketing of such illegal Online lotteries, Fake Lottery Tickets and Satta are spreading at very rapid speed at current time in the different parts and areas of PARA Police Station. The increasing sale of such illegal Online lotteries, Fake Lottery Tickets and Satta, is also posing a big threat to the livelihood of more than 5 Lakhs people who are directly or indirectly related to this trade, and if this trend continues, we fear that they might lose their business and so as the source of earning.

Furthermore since there is no generation of Government Revenue from these illegal Online lotteries, Fake Lottery Tickets and Satta and the same being completely operated by some private persons, the money generated from this illegal business could be used in Hawala and Money Laundering activities apart from causing other law and order related issues. Furthermore on detail survey of the area under your Police Station we have found that one person namely SAUIM KHAN (M. No. 6294288178) son of SALIM KHAN resident of GURGURIA PURULIA WB 723155, SEKH SANJAR (M. No. 7586891988) son of SEKH EKRAR , resident of BAMUNBAD , PARULIA WB 723155 , GOBINDA SWARNAKAR (M. No. 8250403558) son of GHALTU SWARNAKAR , resident of VILL -
