Sub: Complain to start a specific case.

Sir,

In producing here with 05 (five) arrested persons namely (1) Dhanapati Bauri(32), S/O- Madhusudan Bauri of vill-Budhpur, PS-Puncha, Dist- Purulia (2) Santu Kr. Sardar(52), S/O- Lt. Baidyanath Sardar of vill-Tusyama, PS- Puncha, Dist- Purulia (3) Amrit Kr. Bauri(48), S/O- Chhutu @ Chhutulal Bauri of vill-Dhadkidi, PS-Manbazar, Dist- Purulia (4) Biswajit Bauri(40), S/O- Chhutu @ Chhutulal Bauri of do (5) Laxman Ch. Bauri(39), S/O- Chhutulal Bauri of do along with Memo of arrest & other relevant papers.

I beg to state that today (18/07/2021) I was engaged in special mobile duty at PS area with force to find out whether people are following norms of wearing mask & social distancing properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 640 Dtd-18/07/2021. Accordingly when I was performing duty at near Puncha Krishan Mandi I found the above noted people were roaming aimlessly without wearing mask. Firstly I instructed them to wear mask in this pandemic situation but they did not pay heed to my words. Hence I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) duly signed by the accd people. The whole process was done in between 13.30 hrs to 14.25 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Dhanapati Bauri(32), S/O- Madhusudan Bauri of vill-Budhpur, PS-Puncha, Dist- Purulia (2) Santu Kr. Sardar(52), S/O- Lt. Baidyanath Sardar of vill-Tusyama, PS- Puncha, Dist- Purulia (3) Amrit Kr. Bauri (48), S/O- Chhutu @ Chhutulal Bauri of vill-Dhadkidi, PS-Manbazar, Dist-Purulia (4) Biswajit Bauri(40), S/O- Chhutu @ Chhutulal Bauri of do (5) Laxman Ch. Bauri(39), S/O-Chhutulal Bauri of do, as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51(1)(b) of the National Disaster Management Act, 2005 and arrange for its investigation.
