Hon'ble Sir,

In sending here with the original FIR copy, arrest memo, PR & Bail bond of accd. persons namely (1) Manbodh Bauri (29), S/O- Manik Bauri of vill-Baramesya, (2) Prithiraj Paramanik (26), S/O- Ashok Paramanik of vill-Damodarpur, (3) Tarun Mandi (35), S/O- Srikanta Mandi of vill-Chaklalpur, (4) Laxman Sing Sardar (24), S/O- Lt. Mohan Sing Sardar of vill-Haridih, (5) Baidyanath Kishku (21) S/O Laxman Kishku of Vill- Junarbari all of PS- Puncha, Dist- Purulia.

The fact of the case is that on 27/07/2021 received a typed complaint from PSI Sandip Pal as when he was engaged in Mobile duty at near Puncha Kishan Mandi area with force to find out whether the people of this jurisdiction are following norms of wearing mask & social distancing properly at PS jurisdiction area or not vide Puncha PS GDE No- 1068, Dtd- 27/07/2021 at about 17.25 hrs, he found the people that namely (1) Manbodh Bauri (29), S/O- Manik Bauri of vill-Baramesya, (2) Prithiraj Paramanik (26), S/O- Ashok Paramanik of vill-Damodarpur, (3) Tarun Mandi (35), S/O- Srikanta Mandi of vill-Chaklalpur, (4) Laxman Sing Sardar (24), S/O- Lt. Mohan Sing Sardar of vill-Haridih, (5) Baidyanath Kishku (21) S/O Laxman Kishku of Vill- Junarbari all of PS- Puncha, Dist- Purulia were roaming aimlessly without wearing mask so he detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence he arrested them after issuing arrest memo and informed them the ground of arrest duly signed by the accd people as per section 3 of the Epidemic Diseases Act, 1897, for disobeying Govt order vide (Memo No-486-CS/2021 Dated- 24th April, 2021) of compulsory wearing of mask during this pandemic situation. Over this started Puncha PS case no.-45/21, dtd-27/07/21, U/S 188/34 IPC and Sec 51(1)(b) of National Disaster Management Act, 2005 and O/C

Puncha PS endorsed to me to investigate this case.

There after Sanjay Kr. Dutta, S/O- Buddheswar Dutta of Vill-Dhadki, PS-Puncha Dist- Purulia came to PS and turned up surety for arrested accd persons namely (1) Manbodh Bauri (29), S/O- Manik Bauri of vill-Baramesya, (2) Prithiraj Paramanik (26), S/O- Ashok Paramanik of vill-Damodarpur, (3) Tarun Mandi (35), S/O- Srikanta Mandi of vill-Chaklalpur, (4) Laxman Sing Sardar (24), S/O- Lt. Mohan Sing Sardar of vill-Haridih, (5) Baidyanath Kishku (21) S/O Laxman Kishku of Vill- Junarbari all of PS- Puncha, Dist- Purulia. Accordingly O/C Puncha PS released them bail after furnishing proper bail bond and PR bond duly signed by them.

Under the above circumstances I pray before your kind honour that bail of above noted FIR named accd persons may kindly be accepted and obliged.
