Hon'ble Sir,

In sending here with the original FIR copy, arrest memo, PR & Bail bond of accd. persons namely (1) Dilip Laya @ Mahato (48), S/O- Lt. Sufal Laya of vill-Puncha, PS- Puncha (2) Gopinath Tudu (53), S/O- Dasarath Tudu of vill-Muggora, PS- Puncha (3) Amiya Sing Sardar (50), S/O- Lt. Sristidhar Sing Sardar of vill-Loharia, PS- Puncha (4) Chakradhar Sing Sardar (50), S/O- Lt. Rasbihari Sing Sardar of vill-Simakanali, PS- Puncha (5) Chunaram Hansda (42)S/O Lt. Kanka Hansda of Vill- Raghunath Pur(Lakhra) PS – Puncha (6) Labkush Murmu (24) S/O Rameswar Murmu of vill- Panjangora, PS- Hura all of Dist- Purulia.

The fact of the case is that on 28/07/2021 received a typed complaint from SI Sunil Kr. Banerjee as when he was engaged in Mobile duty at near Puncha Kishan Mandi area with force to find out whether the people of this jurisdiction are following norms of wearing mask & social distancing properly at PS jurisdiction area or not vide Puncha PS GDE No- 1105, Dtd- 28/07/2021 at about 13.20 hrs, he found the people that namely (1) Dilip Laya @ Mahato (48 ), S/O- Lt. Sufal Laya of vill-Puncha, PS- Puncha (2) Gopinath Tudu (53), S/O-Dasarath Tudu of vill-Muggora, PS- Puncha (3) Amiya Sing Sardar (50), S/O- Lt. Sristidhar Sing Sardar of vill-Loharia, PS- Puncha (4) Chakradhar Sing Sardar (50), S/O- Lt. Rasbihari Sing Sardar of vill-Simakanali, PS- Puncha (5) Chunaram Hansda (42)S/O Lt. Kanka Hansda of Vill- Raghunath Pur(Lakhra) PS - Puncha (6) Labkush Murmu (24) S/O Rameswar Murmu of vill- Panjangora, PS- Hura all of Dist- Purulia were roaming aimlessly without wearing mask so he detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using next As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence he arrested them after issuing arrest memo and informed them the ground of arrest duly signed by the accd people as per section 3 of the Epidemic Diseases Act, 1897, for disobeying Govt order vide (Memo No-486-CS/2021 Dated-24th April, 2021) of compulsory wearing of mask during this pandemic situation. Over this started Puncha PS case no.-47/21, dtd-28/07/21, U/S 188/34 IPC and Sec 51(1)(b) of National Disaster Management Act, 2005 and O/C Puncha PS endorsed to me to investigate this case.

There after Sanjay Kr. Dutta, S/O- Buddheswar Dutta of Vill-Dhadki, PS-Puncha Dist- Purulia came to PS and turned up surety for arrested accd persons namely (1) Dilip Laya @ Mahato (48). S/O-Lt. Sufal Laya of vill-Puncha, PS- Puncha (2) Gopinath Tudu (53), S/O- Dasarath Tudu of vill-Muggora, PS- Puncha (3) Amiya Sing Sardar (50), S/O-Lt. Sristidhar Sing Sardar of vill-Loharia, PS- Puncha (4) Chakradhar Sing Sardar (50), S/O-Lt. Rasbihari Sing Sardar of vill-Simakanali, PS- Puncha (5) Chunaram Hansda (42)S/O Lt. Kanka Hansda of Vill- Raghunath Pur(Lakhra) PS - Puncha (6) Labkush Murmu (24) S/O Rameswar Murmu of vill- Panjangora, PS- Hura all of Dist- Purulia. Accordingly O/C Puncha PS released them bail after furnishing proper bail bond and PR bond duly signed by them.

Under the above circumstances I pray before your kind honour that bail of above noted FIR named accd persons may kindly be accepted and obliged.
