Respected Sir,

Today (14.07.2021) during my day mobile duty after being informed by duty officer of Purulia (M) PS regarding road blocked at Shidpur village morh on Purulia-Bankura road (NH-60A) and the road was obstructed by the some villagers of Shidpur village over the issue of the one specific alleged person of that village regarding his illegal activities and his arrest. Immediately after receiving the information myself along with force i) C/250 Bomkesh Rajwar & ii) C/2815 Bebakananda Mahato both are Hutmura camp under Purulia (M) PS and i) C/1413 Kanailal Mondal, ii) C/254 Karunamoy Bouri, iii) LC/648 Munmun Bouri, iv) LC/408 Mousumi Paramanik, v) NVF/927 Anup Kr. Bhagat & vi) NVF/269 Praloy Mahato all of Purulia (M) PS vide C.C. No 1972/21 and GDE No 554 Dt. 14.07.2021 rushed to the spot at about 09:25 hrs. and found that the road has been blocked by the rabble of about 200 of Shidpur villagers. After forming unlawful assembly under the leadership of (i) Nirod Baran Ojha @ Niru, S/O- Prafullya Ojha (ii) Gobardhan Bagdi s/o Gokul Bagdi, (iii) Balaram Bagdi S/O-Biras Bagdi (iv) Tapan Bagdi S/o-Gulu Bagdi (v) Subash Bagdi s/o Fuchu Bagdi, (vi) Sita Bagdi w/o Mansu Bagdi (vii) Sovoma Bagdi w/o Bistu Bagdi (viii) Manju Bagdi S/O- Mantu Bagdi (ix) Anna Bagdi w/o Laltu @ Siraj Bagdi, (x) Sakhi Bagdi w/o Bhajan Bagdi, (xi) Alki Bagdi w/o Rasaraj Bagdi, all of Vill- Sidpur, PS- Purulia (M), Dist- Purulia. Subsequently vehicular traffic was totally disrupted and seized along the Purulia-Bankura road. I requested the above noted leaders to with draw the blocked but they paid no heed to my words and they demanded for the immediate arrest the alleged person. Despite of all, I persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied my proposal and deter my duty. I along with force started to disperse them form the road but the road blockers obstructed them adamantly from the discharge of their public functions. After the prolonged discussion the mob withdrew the blocked at 10:25 hrs. Thereafter, the vehicular traffic movement became normal after our assiduous act. As the some villagers of Shidpur village committed offence u/s 188/186/283 IPC & 18 W.B Highway act. 1964 under the leadership of supra noted persons ergo. So a specific case may kindly be initiated against them and arranged for its investigation.


