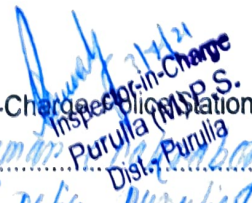

Respected Sir,

My mother Mrs Sadhana Sarkar was
returning from Ranchi to Raghunathpur
by car no. WB82D1212 on 02/July/2021.
During the journey she met with an
accident near Anjor village, P.S. Purulia
Muffasal about 5pm. Due to collision
with another car (NISSAN make) with regn.
no. UP32HQ1917 which was coming from
opposite side in high speed and riding
in a rough and rash driving with negli-
gence by the driver and my mother received
grievous injury. My mother was immediately taken
to Kustaur Hospital from where she was
referred to Purulia Sadar Hospital,
Distt. Purulia. She was declared dead
at Purulia Sadar Hospital.

The above could not be informed
yesterday as we were mentally very
shocked and disturbed about the
incident.
