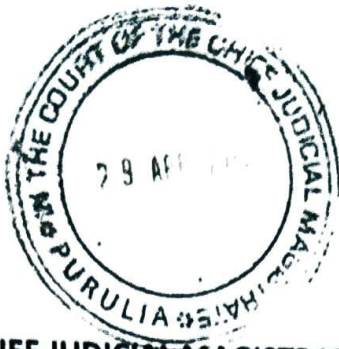

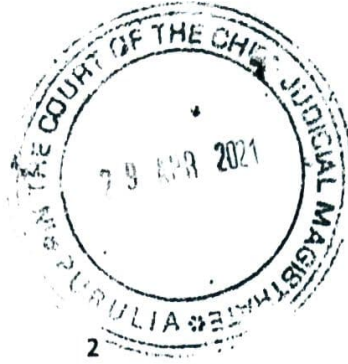

1...That the complainant is a resident of Nilkuthidanga, P.O. Purulia, P.S. Purulia (T), District- Purulia, West Bengal, and within the jurisdiction of this Ld. Court and the accused is a resident of Puabagan, Saradanagar, P.O. Puabagan, P.S. Bankura, District- Bankura, and also running a Institute as a Director under the name and style of "CAMA COLLEGE" (Career Academy of Medical Science) situated at Puabagan, P.O. Puabagan, P.S. Bankura, District- Bankura.

2...That on 9/11/2020 the accused person came to the house of complainant at "Sarada Palli" Nilkuthi Danga, accompanied with one Gopeswar Gorain of ^{Nilkuthi - Purulia} Purulia, and introduced him as a Director of "CAMS COLLEGE" (Near Engineering College),

Saradanagar, Puabagan, P.O. Puabagan P.S. Bankura, District- Bankura, and promised the complainant that he would get admission his son in the government college for male nursing course situated at Bagha Jatin at Kolkata and for the purpose of admission in management quota he asked to pay the complainant Rs. 4, 00,000/- (Rupees four lacks) on condition that he will refund the same if the accused person failed to get admission of her son in the said course.

3...That accused person also earning the faith of the complainant shown the Gopeswar Gorain and said that his three daughters were got admission in the government college of Nursing through accused person's institution and one of the daughter of the said Gopeswar Gorain named Sanaka Gorain is now serving as Nurse at a BPHC in the District of Purulia. Then the complainant on good faith and on the pretext of the future of his son paid the accused person on the same day i.e. on 9/11/2021 paid Rs.20, 000/- Cash and one cheque bearing no. 626334 dated 9/11/2020 drawn upon S.B.I. Purulia Bazar Branch, Ranchi Road, Purulia and same was en cashed by the accused person.

4...That after two month when the complainant contacted the accused person the whether his sons has been selected for the admission of the course which he promised and received Rs.4 lacks for the same but the accused person avoided to give any answer and later on ignored to received the complainants call.

5...That on 5/04/2021 the complainant visited the complainants "CAMS COLLEGE" at Saradanagar, Puabagan, Bankura and asked him to return back the amount of Rs.4,00,000/- which the accused person by hatching criminal conspiracy, fraudulently received from the complainant on the pretext of admission of the complainant's son in government running male nursing course, but the accused person did not pay any heed to the complainant instead he thrown out the complainant from his college, by physically assaulting him through his security guard of the CAMS college and accused person also threaten the complainant with dire consequences if the complainant further tried to meet him.

6...That the accused person such way committed an offence of cheating, criminal breach of trust and also assaulted the complainant and threaten the complainant with dire consequences.

7...That the complainant reported the matter to the Town P.S. but the reason best known to him the duty officer on table refused to received any written complaint against the accuse person nor he allowed to meet him with the I.C. of the same P.S.

8...That on 8.04.2021 the complainant send his typed complaint to the I.C. Purulia through registered post but till date no action has been taken against the accused person above named.

9...That on 16.04.2021 the complainant reported the matter to S.P. Purulia, but till days no action have been taken against the accused persons for such heinous act on their part against the complainant.
