I beg to report that on 30.06.2021 at 21:15 hrs, I/C Purulia (T) PS received a secret information that one gambling with huge amount was going on at Room No- 404 of Akash Sarovar Hotel, Near Saheb Bandh under Purulia(T) PS. The matter was diarised vide Purulia (T) PS G.D.E No- 1091 Dtd.- 30.06.2021. Accordingly as per order of I/C Purulia(T) PS I S.I Keshab Chatterjee along with (1) SI Subrata Sarkar (2) PSI Suvajit Nandi (3) ASI Ujjal Rajak (4) NVF/797 Badal Singh Mura (5) HG/1442 Shanti Kundu (6) C/2041 Uttam Man (7) C/3192 Tarun Sahoo vide C.C No- 1756/21 in Govt. vehicles left for Akash Sarovar Hotel to work out the information. At about 21:30 hrs. we reached at Akash Sarovar Hotel and very slowly and cautiously approached towards Room No- 404 where the gambling was reportedly going on. From the stair case we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money & Coin causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One White Bed sheet on the floor) and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash and coin for wrongful loss to one and wrongful gain to another. We asked the manager and hotel staff to be public witness and they agreed. After that in presence of witnesses the board money of Rs 1,18,275 (One Lakh Eighteen Thousand Two Hundred & Seventy Five Rupees only) with different denomination, 52 nos of Playing cards and One White Bed sheet were seized for the gaming board in between 21:45 hrs. to 22:05 hrs. under proper seizure list. Then in presence of public witnesses we searched their persons and found some personal belonging, cash (Rs 17,000/- in total) and Phones etc. All articles were seized under proper seizure list as personal property from 22:10 hrs. to 22:50 hrs. duly signed by hotel staff and copy was supplied to them.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 12 (Twelve) persons were arrested, issuing arrest memo and Inspection memo between 22:50 hrs. to 23:25 hrs.

It was also revealed that the gaming was going on under guidance and full knowledge of the said Akash Sarovar Hotel owners.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons along with the owners of Akash Sarovar Hotel and others and arrange for its investigation.
