I Sri Debjit Adhikary, son of Late Santosh Kumar Adhikary, residing at Namopara, Municipality ward No. 16, Post & P.S. & District Purulia.

Do here by like to ventilate by utmost grievance that on 08/06/21 at about 10.30 p.m, my brother namely Satyajit Adhikari along with his two friends Jyodipto Chattraj and Arijit DhawalBbabu went to arrange Oxygen Cylinder at Shaktisanga Club Chock Bajar Purulia. While they were standing near the said club, a group of miscreants embolden with deadly weapons attack them with dare consequences and in mean while

And others 5 to 10 persons started assaulting them with lathi, Iron rod, fist and Blow mercilessly with an intention to murder them. My brother Satyajit Adhakary & one of his friend Jyodipto Chattraj were admitted to Sadar Hospital Purulia on the same night and next day they were referred to RIMS Hospital Ranchi. Due to such assault my brother and his friend sustain grievous injury.

Under the above facts and circumstances I request you after submitting me my application you will take necessary steps against the aforesaid persons.

Please treat the same as urgent.
