Sir,

In producing herewith one arrested accused persons namely (1) Shaktipada Bauri (67) S/o Late Arjun Bauri of Vill.- Biltora, PS - Raghunathpur, Dist.- Purulia, (2) Tapan Bauri (53) S/o Late Adhor Bauri of Do and (3) Prakash Bauri (45) S/o Lt. Mahadeb Bauri of Do under arrest along with seized articles as per seizer list i.e. (i) 27 (Twenty Seven) bottles country spirit measuring 300 ml each styled as Dilkush, (ii) 11 (Eleven) bottles country spirit measuring 600 ml each styled as Dilkush, (iii) 07 (Seven) bottles country spirit measuring 600 ml each styled as Dilse kept in a 02 (two) white plastic bags under proper seizure with label.

I SI Subhash Malik of Raghunathpur PS hereby lodged a written complaint against the above noted accused persons to the effect that on 09.07.2021 at about 18:35 hrs during my special mobile duty I received a credible source information that the above noted accused persons were selling country spirit illegally at Biltora village under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with C/06 Debdas Mukherjee and C/853 Kiran Ch. Murmu both of Raghunathpur PS left to work out the information (This refers to Raghunathpur PS CC No. 1590/21 dated 09/07/2021). At 19:05 hrs we reached at Biltora village more at abandoned gumthi and my source shown the persons from distances who were selling the liquors in lonely place. We immediately reached there and surrounded them, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot and found the huge quantity of country spirit bottles were kept there in concealing condition. On searched (i) 27 (Twenty Seven) bottles country spirit measuring 300 ml each styled as Dilkush, (ii) 11 (Eleven) bottles country spirit measuring 600 ml each styled as Dilkush, (iii) 07 (Seven) bottles country spirit measuring 600 ml each styled as Dilse kept in a 02 (two) white plastic bags were found there. On demand they failed to produce any license / authority of the said liquors. On interrogation they also made incoherent statement regarding possession of said liquors and told that they are usually selling the same to the villagers/pedestrian illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused persons and labeled, duly signed by the accused persons & witnesses in between 19:45 hrs to 20:25 hrs in which One each bottle of Dilkush 300 ml, Dilkush 600 ml and Dilse 600 ml were kept as sample file with label. During interrogation they confessed their guilt as such I arrested them at 20:35 - 20:45 hrs after observing all the formalities as per law issuing memo of arrest as the accused persons are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused persons namely (1) Shaktipada Bauri (67) S/o Late Arjun Bauri of Vill.- Biltora, PS - Raghunathpur, Dist.- Purulia, (2) Tapan Bauri (53) S/o Late Adhor Bauri of Do and (3) Prakash Bauri (45) S/o Lt. Mahadeb Bauri of Do u/s-46A (c) of the Bengal Excise Act 1909.
