Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect 1 beg to submit before you that on 11/07/2021 at about 23:15 hrs. while I, SI Biswajit Sarkar along with C/985 Laxman Majhi, C/351 Kanailal Bauri, C/929 Rajendra Das and PSI Mekdam Sabab, C/1068 Ranajit Mandal, LC/910 Bulti Moni vide CC No. 1612/21 and 1614/21 dated-12.07.2021 were engaged on mobile duty as well as Naka Checking at Raghunathpur Traffic more and found the following persons were coming from Barakar side in white colour four wheeler vehicle bearing No. JH 05BS/7161 aimlessly and not wearing mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that coming aimlessly without mask in this pandemic situation and violation of social distancing. I requested them for producing pass regarding their movement in pandemic situation but they failed to produce any valid documents and adamantly they try to obstruct on duty police who were on duty with full uniform and the following accused persons assaulted the police. As a result PSI Mekdam Sabab, C/351 Kanailal Bauri and LC/910 Bulti Moni received injuries on their persons and arranged to shift them to Raghunathpur S.S. Hospital for treatment. The following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide No. 753/II-ISS/2M-22/2020 dated- 28/06/2021, 753-ISS/2M-22/2020 dated- 14.06.2021, No. 647-ISS/2M-22/2020 dated- 15.05.2021 of Chief Secretary, West Bengal, Memo No. 486-CS/2021 dated- 24.04.2021 and Order No. 79-CS/2020 dated- 12.04.2020 and they are responsible for their negligent Act and malignant Act likely to spread infection of disease dangerous to life. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and seized the above noted vehicle and brought them to PS.

1) Vivek Kumar Singh (42) S/o Upendra Singh of Jyoti Nagar, Khangajhar, PO - Telco, PS - Telco, Jamshedpur, Purbi Singhbhum, Jharkhand - 831004

2) Sarita Singh (41) W/o Vivek Kumar Singh of Do.

3) Jyoti Kumari (21) D/o Manoj Kumar of H. No. 39 Manifit, Oriya Basti, Near Telecon Gate, PS -Telco, Dist.- East Singhbhum, Jharkhand.

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
