In producing herewith the arrested accused persons namely (1) Sarbasish Dutta @ Tarun Kr Dutta (58) S/o Late Hare Krishna Dutta of Jhandapara, Ward No 6, PS – Raghunathpur, Dist.- Purulia (2) Sekh Manowor (38) S/o Late Sekh Sahaban of Balichura, Ward No 5, PS – Raghunathpur, Dist.- Purulia (3) Sk Ibrahim @ Jamai (57) S/o Late Sk Hamdul of Balichura, Ward No 7, PS – Raghunathpur, Dist.- Purulia and (4) Prasanta Addya S/o Late Bablu Addya of A-Team Ground, Ward No 13, PS – Raghunathpur, Dist.- Purulia along with seized articles like (1) Total Board Money amounting to Rs. 7660/- (14 Nos. of 500 rupee note, 06 Nos. of 100 rupee note and 3 Nos. of 20 rupee note), (2) 31 number of Playing Cards, (3) 01 Pc. half burnt candle, (4) 04 Nos. of Old Bengali News Papers and (5) 03 (three) motorcycles having No. (a) WB 26AR/7573 of Honda Navi, (b) WB 82A/9656 of Hero Maestro Edge and (c) Without number plate of Honda Dio red and black colour having Engine No. JF98EW0041851, Frame No ME4JF981JLW025417.

I beg to report that on 13.07.2021 at 21:05 hrs I SI Indrajit Sarkar along with C/140 Subrata Banerjee, NVF/1089 Swapan Paramanik and C/844 Tufan Swadagar was performing 2<sup>ND</sup> Night Mobile Duty at Raghunathpur PS area. During said duty I received secret information that one gambling with huge amount was going on at Old abandoned waiting hall at Rakshatpur more under Raghunathpur PS. Informed the matter to I/C Raghunathpur PS. Accordingly, as per order of IC Raghunathpur PS I along with force left for Rakshatpur more to work out the information. At about 21:25 hrs we reached at spot and very slowly and cautiously approached towards where the gambling was reportedly going on. From the stair case we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associates staffs to cordon the place and within a moment the place was cordoned by police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels and mobile phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on 04 Nos. of old Bengali news papers and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash for wrongful loss to one and wrongful gain to another. After that in presence of witnesses the Total Board Money amounting to Rs. 7660/- (containing 14

Nos. of 500 rupee note, 06 Nos. of 100 rupee note and 3 Nos. of 20 rupee note), (2) 31 number of Playing Cards, (3) 01 Pc. half burnt candle, (4) 04 Nos. of Old Bengali News Papers and (5) 03 (three) motorcycles having No. (a) WB 26AR/7573 of Honda Navi, (b) WB 82A/9656 of Hero Maestro Edge and (c) Without number plate of Honda Dio red and black colour having Engine No. JF98EW0041851, Frame No ME4JF981JLW025417 seized under proper seizure list duly signed by the available witnesses in between 21:45 hrs to 22:15 hrs

As such for committing offence punishable U/S 3 & 4 of W.B.G. & P.C. Act all the above noted 04 (four) persons were arrested, issuing arrest memo and inspection memo in between 22:25 hrs 22:45 hrs.

Therefore I pray before you that one specific case may kindly be started under proper section of law against the arrested accused persons namely (1) Sarbasish Dutta @ Tarun Kr Dutta (58) S/o Late Hare Krishna Dutta of Jhandapara, Ward No 6, PS – Raghunathpur, Dist.-Purulia (2) Sekh Manowor (38) S/o Late Sekh Sahaban of Balichura, Ward No 5, PS – Raghunathpur, Dist.- Purulia (3) Sk Ibrahim @ Jamai (57) S/o Late Sk Hamdul of Balichura, Ward No 7, PS – Raghunathpur, Dist.- Purulia and (4) Prasanta Addya S/o Late Bablu Addya of A-Team Ground, Ward No 13, PS – Raghunathpur, Dist.- Purulia.
