Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 15/07/2021 at about 14:25 hrs. while I, SI Muktipada Ghosh along with C/1325 Sunil Kr Mahato, C/666 Sanjib Goswami and C/1068 Ranajit Mondal vide CC No 1644/21 dated- 15.07.2021 were engaged on mobile duty in Raghunathpur Town area and found the following persons were moving at Adra More, Raghunathpur aimlessly and not wearing mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly without mask in this pandemic situation and violation of social distancing. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide No. 753-ISS/2M-22/2020 dated- 14.06.2021, No. 647-ISS/2M-22/2020 dated- 15.05.2021 of Chief Secretary, West Bengal, Memo No. 486-CS/2021 dated- 24.04.2021 and Order No. 79-CS/2020 dated- 12.04.2020 and they are responsible for their negligent Act and malignant Act likely to spread infection of disease dangerous to life. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

- 1) Nityananda Kaibartya (39) S/o Bibhuti Bhusan Kaibartya of Vill.- Biltora, PS – Raghunathpur, Dist.- Purulia.

- 3) Somnath Kalindi (23) S/o Brindaban Kalindi of Saltora, PS – Saltora, Dist.- Bankura.
- 4) Sukumar Roy (38) S/o Panchanan Roy of Vill.- Biltora, PS – Raghunathpur, Dist.- Purulia.
- 5) Rajib Saha (20) S/o Sugun Saha of Near Borokali Mandir, Ward No 1, PS – Raghunathpur, Dist.- Purulia.
- 6) Baidyanath Soren (50) S/o Manshi Soren of Vill.- Latulbaid, PS – Santuri, Dist.- Purulia.
- 7) Jeet Maji (23) S/o Shyamapada Maji of Vill.- Gobindapur, PO – Rakshatpur, PS – Raghunathpur, Dist.- Purulia.

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
