This is to inform you that on 14.07.2021 during a inspection by undersigned it is found that some portion of HTOH 33kV DVC feeder line at near Ghutitora and Durmut Village, emanated from Raghunathpur 132/33 kV sub-station, is missing. During last March 2021 the said line had been inspected by HT maintenance team of Dumurkhola 33/11kV sub-station. Then the line was in good condition.

The conductor of the said portion along with some accessories may be stolen by unknown miscreant. Approximate loss due to the above incident comes to the tune of Rs. 90,000.00.

In reference to the above you are requested to please look into the matter and take needful action as per law.
