Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 21/07/2021 at about 21:15 hrs. while I, SI Muktipada Ghosh along with force vide CC No 1712/21 dated- 21.07.2021 were engaged on mobile duty in Raghunathpur Town area and found the following persons were moving at Bhandur More, Raghunathpur aimlessly and not wearing mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly without mask in this pandemic situation and violation of social distancing. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide No. 753/III-ISS/2M-22/2020 dated- 14.07.2021 and they are responsible for their negligent Act and malignant Act likely to spread infection of disease dangerous to life. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

- 1) Amitesh Kumar Mondal (29) S/o Dilip Mondal of Vill.- Sonabad, PS – Pindrajora, Dist.- Bokaro, Jharkhand.
- 2) Samrat Mondal (22) S/o Paresh Mondal of Raghunathpur, Ward No 3, PS – Raghunathpur, Dist.- Purulia.
- 3) Dhiraj Kumar Mondal (21) S/o Dilip Kumar Mondal of Vill.+PO – Ghatiyali, PS Pindrajora, Dist.- Bokaro, Jharkhand.
- 4) Chandan Bauri (29) S/o Dilip Bauri of Paisapara, Ward No 1, PS – Raghunathpur, Dist.- Purulia.
- 5) Shuvendu Bauri (23) S/o Tapas Bauri of Paisapara, Ward No 3, PS – Raghunathpur, Dist.- Purulia.

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
