Sir,

In producing herewith arrested accused persons (1) Gorachand Mahato (22), S/O Sib Charan Mahato of Kumardih, PS- Santaldih, (2) Shyamapada Bauri (50), S/O Sakti Bauri of Barrah, Ps- Raghunathapur, (3) Ramesh Chandra Mahato (32), S/O Lt. Adu Mahato of Kumardih, PS- Santaldih, (4) Ajoy Kumbhakar (29), S/O Shakari Kumbhakar of Ichhar, PS- Santaldih, (5) Dharmendra Kr. Roy, (36), S/o- Jitu Roy, of Fulsuri, PS- Para, All are Dist- Purulia & (6) Dablu Bauri (46), S/o - Latuna Bauri, of Nitch Bazar (Bauri Kuli) Bhojudih, Ps- Chandankiyari, Dist- Bokaro (Jharkhand). I SI Biswajit Murmu, In-charge of Santaldih I/C BCW do hereby lodged this complaint that today (13/07/2021) at 16.05 hrs, when myself along with force were engaged in course of mobile duty at BCW Bus stand area, found the above noted persons were moving at BCW Bus stand area under Santaldih PS, without wearing Mask or any face guard, as such I detained them on that spot. On being asked the above noted persons could not able to give any satisfactory answer for not wearing Mask / face guard in this pandemic situation and loitering without any purpose. As such the above noted persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide order no. 647-ISS/2M-22/2020, Dated-15.05.2021. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly, the above noted persons were arrested after maintaining all the formalities regarding arrest and brought them to PS.

Under above circumstances I therefore pray that a case U/S 188/34 IPC & read with section 51(1)(b) of National Disaster Management Act, 2005 may kindly be initiated against Six (06) arrested accused persons namely (1) Gorachand Mahato (22), S/O Sib Charan Mahato of Kumardih, PS- Santaldih, (2) Shyamapada Bauri (50), S/O Sakti Bauri of Barrah, Ps- Raghunathapur, (3) Ramesh Chandra Mahato (32), S/O Lt. Adu Mahato of Kumardih, PS- Santaldih, (4) Ajoy Kumbhakar (29), S/O Shakari Kumbhakar of Ichhar, PS- Santaldih, (5) Dharmendra Kr. Roy, (36), S/o- Jitu Roy, of Fulsuri, PS- Para, All are Dist- Purulia & (6) Dablu Bauri (46), S/o - Latuna Bauri, of Nitch Bazar (Bauri Kuli) Bhojudih, Ps- Chandankiyari, Dist- Bokaro (Jharkhand), and arrange for investigation.
