With due respect and humble submission, I beg to submit that I SI Mrinmay Bhakta along with C/330 Banamali Soren and C/863 Rupchand Pauria both of Santuri PS on 09/07/2021 at 16:05 hrs received a credible source information that some Bi-Cycles and Scooters loaded with coal which have been procured by means of theft or any fraudulent manner are proceeding towards Santuri side from Raghunathpur side through Raghunathpur-Saltora road (SI-81). After receiving the said information we have started NAKA checking duty near Marbedia under our P.S jurisdiction with a view to intercept the said Bi-Cycles and Scooters. At about 16:45 hrs we found the aforesaid 05(Five) Bi-Cycles and 02(Two) Scooters with out any number plate are coming from Hansdima Morh side and seeing police party at near Marbedia Morh the rider of the said Bi-Cycles and Scooters tried to flew away by stopping the Bi-Cycles and Scooters on road. We have apprehend the riders namely 1) Sk Rahaman (60 Yrs) , S/O- Lt Abu Ansar, 2) Sk Sabdul (50Yrs), S/O- Sk Azad , 3) Sk Sukur (35Yrs), S/O- Sk Sarfurdin , 4) Sk Irbaj (21 Yrs), S/O- Sk Gafur , 5)Sk Sajid (30Yrs), S/O- Sk Nayeb all are Vill.- Murulia ,PS- Santuri, Dist-Purulia and 6)Beehen Hari (28Yrs), S/O- Lt. Sridam Hari, 7) Apu Acharyya (39Yrs), S/O- Ajit Acharyya both are Vill - Gorshika, PS- Santuri, Dist-Purulia. On reaching near said Bi-Cycles and Scooters I along with my accompanying force searched the Bi-Cycles and Scooters and found that the Bi-Cycles and Scooters were carrying coal. No such document could be found in respect of said coal loaded Bi-Cycles and Scooters. It is reasonable to believe that the riders of the said Bi-Cycles and Scooters and others collected the said coal either theft or by any illegally means and transporting to run a clandestine business for wrongful gains and habitual to run this business. So, I have seized the said 05(Five) Bi-Cycles and 02(Two) Scooters along with loaded approx 150 kgs coal in each under proper seizure list. I have also sealed & labeled approx 01 (one) K.G coal as sample from the 07 (Seven) major contrabands. There was no such public witness available at the time of seizure. Thereafter I brought the seized 05(Five) Bi-Cycles and 02(Two) Scooters along with loaded approx 150 kgs coal in each at Santuri P.S compound.

I therefore pray before you to lodge a specific case against the riders of the 05(Five) Bi-Cycles and 02(Two) Scooters and others under proper section of law.
