

Respected Sir,

I, PSI Mrinmay Bhakta S/O- Swapan Kr Bhakta of Vill.- Tantipara, P.S - Chandrapur, Dist- Birbhum do hereby produce (1) Rahul Tudu (19 yrs), S/O-Suku Tudu, Vill- Jagannathdih, (2) Rajdut Mondal (35 Yrs) S/O- Lt. Sudhakar Mondal, Vill- Balitora, (3) Manaj Misra (30 yrs) S/O-Lt. Sudhir Kumar Misra, Vill- Sunuri, (4) Sk Sikandar (24 Yrs) S/O- Sk Manu, Vill- Murulia and (5) Ganesh Chandra Mandal (61 Yrs) S/O- Nabanidhar Mandal, Vill- Dhekshila all are PS-Santuri, Dist- Purulia & do hereby lodge a written complaint against them, to the effect that today on 18.06.2021 while I along with C/1052 Shyamal Murmu & NVF/768 Shibal Majhi of Santuri PS as per direction engaged in Special mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 689 dtd. 18.07.2021 vide C.C. No. 2319/21 dtd. 18.07.2021) for implementation of Government rules regarding Disaster Management Plan. On 18.07.2021 while we returning from Rambhattadil side under Santuri P.S jurisdiction and reached at Sadhusaltora Morh through Raghunathpur-Saltora Road at about 21:15 hrs. found that the above noted 05(Five) persons were gossiping near Sadhusaltora Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 647-ISS/2M-22/2020 Dated- 15th May 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Rahul Tudu (19 yrs), S/O-Suku Tudu, Vill- Jagannathdih, (2) Rajdut Mondal (35 Yrs) S/O- Lt. Sudhakar Mondal, Vill- Balitora, (3) Manaj Misra (30 yrs) S/O-Lt. Sudhir Kumar Misra, Vill- Sunuri, (4) Sk Sikandar (24 Yrs) S/O- Sk Manu, Vill- Murulia and (5) Ganesh Chandra Mandal (61 Yrs) S/O- Nabanidhar Mandal, Vill- Dhekshila all are PS-Santuri, Dist- Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
