I, PSI Mrinmay Bhakta S/O- Swapan Kr Bhakta of Vill.- Tantipara, P.S - Chandrapur, Dist.- Birbhum do hereby produce (1) Manaj Murmu (26 yrs), S/O-Lt. Magaram Murmu, Vill- Jagannathdih, (2) Arun Ruhidas (19 Yrs) S/O- Manash Ruhidas, Vill- Kalipahari, (3) Mahesh Sing (35 Yrs) S/O- Ramji Sing, Vill- Krishnapur bazaar, (4) Bishnu Sing (28 Yrs) S/O- Ranji Sing, Vill- Krishnapur bazar, all are PS-Santuri, Dist- Purulia (5) Prakash Mahato (22 yrs) S/O-Rishikesh Mahato, Vill- Dumuria, PS- Khatra, Dist- Bankura & do hereby lodge a written complaint against them, to the effect that today on 29.07.2021 while I along with C/1333 Dilip Kumatr Mahato & NVF/426 Morol Besra of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 1152 dtd. 29.07.2021) for implementation of Government rules regarding Disaster Management Plan. On 29.07.2021 while we were returning from Marbedia side under Santuri P.S jurisdiction and reached at Hansdima Morh through Raghunathpur-Saltora Road at about 22:05 hrs. found that the above noted 05(Five) persons were gossiping near Hansdima Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 647-ISS/2M-22/2020 Dated- 15th May 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Manaj Murmu (26 yrs), S/O-Lt. Magaram Murmu, Vill- Jagannathdih, (2) Arun Ruhidas (19 Yrs) S/O- Manash Ruhidas, Vill- Kalipahari, (3) Mahesh Sing (35 Yrs) S/O- Ramji Sing, Vill- Krishnapur (4) Bishnu Sing (28 Yrs) S/O- Ranji Sing, Vill- Krishnapur, all are PS-Santuri, Dist- Purulia (5) Prakash Mahato (22 yrs) S/O- Rishikesh Mahato, Vill- Dumuria, PS- Khatra, Dist- Bankura under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
