Respected Sir,

In producing here with the arrested accused person Basudeb Mondal (58 Yrs), S/O- Lt. Hantu Mondal of Vill- Marbedia, P.S - Santuri, Dist - Purulia along with 15 (Fifteen) bottle Country Spirit design as "DIL KHUSH" containing 600 ML each bottles. seized under proper seizure list, I beg to submit that today (on 30.07.2021) at about 17:55 hrs received a credible source information that one person namely Basudeb Mondal (58 Yrs), S/O- Lt. Hantu Mondal of Vill- Marbedia, P.S - Santuri, Dist - Purulia is stocking and selling Country Spirit without any valid license from his dwelling house at Vill-Marbedia, P.S - Santuri, Dist - Purulia. Accordingly, I along with mobile officer PSI Mrinmay Bhakta and C/233 Upananda Das, NVF/426 Moral Besra had been to Marbedia village at about 19:25 hrs. to work out the source information and held raid into the premises of above mentioned accused person. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I seized 15 (Fifteen) bottles country spirit design as "DIL KHUSH" containing 600 ML each bottles under proper seizure list duly signed by the witnesses out of which one bottle is sealed and labeled as sample and arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Basudeb Mondal (58 Yrs), S/O- Lt. Hantu Mondal of Vill- Marbedia, P.S - Santuri, Dist - Purulia and arrange for its investigation.
