I , PSI Mrinmay Bhakta S/O- Swapan Kr Bhakta of Vill.- Tantipara, P.S - Chandrapur, Dist.- Birbhum do here by produce 08 (Eight) arrested accused persons namely (1) Nimai Mishra (50 yrs), S/O-Lt. Giridhari Mishra, Vill- Sunuri (2) Uttam Bauri (37 Yrs) S/O- Lt. Lambu Bauri, Vill- Sunuri (3) Suresh Mudi (34 Yrs) S/O- Lt. Khokan Mudi, Vill- Bankulia (4) Mona Mudi (52 Yrs) S/O- Lt. Sobi @ Subi Mudi, Vill- Bankulia (5) Uttam Mondal (53 Yrs), S/O- Lt. Mahadeb Mondal, Vill- Goyalberia (6) Dulal Mondal (50 Yrs), S/O- Lt. Mahadeb Mondal, Vill- Goyalberia (7) Ayen Maji (40 Yrs), S/O- Lt. Patitpaban Maji, Vill- Balitora (8) Rabilochan Murmu (48 Yrs), S/O- Mansaram Murmu, Vill- Jagannathdih all are PS-Santuri, Dist- Purulia & do hereby lodge a written complaint against them, to the effect that today on 30.07.2021 while I along with C/233 Upananda Das & NVF/426 Morol Besra of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 1176 dtd. 30.07.2021) for implementation of Government rules regarding Disaster Management Plan. On 30.07.2021 while we were returning from Muradi side under Santuri P.S jurisdiction and reached at Muradi GP More at about 20:25 hrs. found that the above noted 08 (Eight) persons were gossiping near Muradi GP More without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No. 647-ISS/2M-22/2020 Dated- 15th May 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Nimai Mishra (50 yrs), S/O-Lt. Giridhari Mishra, Vill- Sunuri (2) Uttam Bauri (37 Yrs) S/O- Lt. Lambu Bauri, Vill- Sunuri (3) Suresh Mudi (34 Yrs) S/O- Lt. Khokan Mudi, Vill- Bankulia (4) Mona Mudi (52 Yrs) S/O- Lt. Sobi @ Subi Mudi, Vill- Bankulia (5) Uttam Mondal (53 Yrs), S/O- Lt. Mahadeb Mondal, Vill- Goyalberia (6) Dulal Mondal (50 Yrs), S/O- Lt. Mahadeb Mondal, Vill- Goyalberia (7) Ayen Maji (40 Yrs), S/O- Lt.
