So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.

Therefore, I pray a specific case may kindly be started against accused produce (1) Bhiswa Gorain (54 Yrs), S/O- Lt. Nakul Gorain of Vill- Ragma, PS- Barabazar, Dist- Purulia (2) Luben Mudi (21 Yrs) S/O- Madhu Mudi of Vill- Beldih, PS- Arsha, Dist- Purulia, (3) Mritunjoy Sahis (45 Yrs) S/O- Ram Chandra Sahis of Vill- Satsayardih, PS- Barabazar, Dist- Purulia, (4) Jayanta Mahato (21 Yrs) S/O- Santosh Mahato of Vill- Arsha, PS- Arsha, Dist- Purulia and (5) Ananda Gorain (36 Yrs) S/O- Srishtidhar Gorain of Vill+P.O.- Chordra, PS- Kenda, Dist- Purulia, under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.
