Respected Sir,

In producing herewith one arrested accused person namely Hem Sahis (58 yrs) S/O- Lt. Sankar Sahis of Vill- Manara Sahis Para, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 24.07.2021 at about 18:05 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I ASI Gnan Sankar Pati of Tamna PS along with force had been to Manara village under Tamna PS at 18:25 hrs and as per indication conducted raid in the house of Hem Sahis S/O- Lt. Sankar Sahis of Vill- Manara Sahis Para, P.S- Tamna, Dist.- Purulia and found 2/3 persons fled away from his house and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his residing. As such I seized (i) 41 (Forty One) Liters of ID Liquor in a plastic container, some portion of ID Liquor as sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Hem Sahis (58 yrs) S/O- Lt. Sankar Sahis of Vill- Manara Sahis Para, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Hem Sahis (58 yrs) S/O- Lt. Sankar Sahis of Vill- Manara Sahis Para, P.S- Tamna, Dist.- Purulia
