So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them and maintaining all legal formalities as well as notifying the ground of their arrest.
